

LEGAL NOTICE

In order to comply with the provisions of Law 34/2002, of 11 July, on Information Society Services and Electronic Commerce, the general information details of this website are given below:

This website, including the set of web pages that make it up, (hereinafter "Website") belongs to Enjoytravel Corporate, S.L., through which users or customers of the same (hereinafter "User" or "Users") can access various information and services on travel and tourism.

All access to this Website is subject to each and every one of these General Conditions of Use of the Website (hereinafter, "General Conditions"), in the version published and in force at the time the User accesses the Website. Therefore, it is mandatory that the User carefully reads the General Conditions before using the Website, as well as the particular conditions that, if applicable, complement, modify or replace the General Conditions in relation to certain services and contents of the Website, given that they may have undergone modifications since the last time the User accessed the Website.

The User declares that he/she is of legal age and has the legal capacity to acquire the services offered through the Website.

Access to the Website is prohibited to Users residing in jurisdictions where its content is unauthorized.

1. Contracting services through the website

This Web Site is aimed at the end consumer, and may only be used for the purpose of gathering information to make a purchase on it, not allowed to use it for other purposes without the express written consent of the owner of this Web Site.

By way of example but not limitation, it is not permitted:

- a) Use the Website in contravention of current legislation, good faith, generally accepted uses and public order.
- b) Use the Web Site with harmful purposes against Enjoytravel Corporate, S.L. or any third party, or that, in any way may cause damage or impede the normal operation of the Web Site.
- c) Introduce in the network programs susceptible to cause damage to the computer systems of Enjoytravel Corporate, S.L., in the company that provides tourist or travel services (hereinafter the "Service Provider"), suppliers or third party users of the internal network or the Website.
- d) Include website information in price comparison search tools.
- e) Accessing the Website by means of a robot, spider or any automatic search tool or program.
- f) Conducting mass searches in proportion to the purchases made on the Website.
- g) Engaging in speculative, false or fraudulent solicitation or contracting.

Without prejudice to the above, Enjoytravel Corporate, S.L. reserves the right to deny at any time, without prior notice and without the right to compensation, access to the Web Site, to those Users who do not comply with these General Conditions, or the particular ones that in each case are applicable to them. If Enjoytravel Corporate, S.L. has reasonable grounds to consider that an order has been placed in contravention of these General Conditions, it will be authorized to cancel it and may inform the relevant authorities.

The Users must know that the contracting of the aforementioned services is governed by the specific or particular contractual conditions, according to the applicable legislation in each case, which are agreed by the Users with the Service Provider of the same and Enjoytravel Corporate, S.L..

In particular the following conditions shall apply generally:

Browser and operating system

The screens of the Web Site are optimized for use with Internet Explorer 6 and Firefox 2 (and higher versions), Safari, Chrome and Opera browsers under Windows , Mac and Linux environments. Enjoytravel Corporate, S.L. is not responsible for the results or damages that may be caused to users by the use of other browsers, different versions, or operating system, other than those for which the Web Site has been designed.

The information contained in the Web Site is offered for the convenience of the Users. Enjoytravel Corporate, S.L. makes the maximum efforts to avoid any error in the contents that could appear in the Web Site. However, Enjoytravel Corporate, S.L. is not responsible for the information that the user can obtain through links to external systems that do not depend on Enjoytravel Corporate, S.L.

Enjoytravel Corporate, S.L. adopts reasonably adequate security measures. However, the user must be aware that the security measures of computer systems on the Internet are not entirely reliable and that the service depends on vulnerable external and internal elements.

Additionally, Enjoytravel Corporate, S.L. makes reasonable efforts to keep the Web Site updated and in good working order. However, Enjoytravel Corporate, S.L. is not responsible or guarantee that access to the Web Site is infallible, continuous or free of deficiencies. 3. Data protection

In compliance with the provisions of Law 15/1999, of December 13, Protection of Personal Data, we inform you that the personal data you provide will become part of an automated file whose owner and responsible is **Enjoytravel Corporate**, S.L. with registered office at Carretera de Sant Cugat a Rubí, KM 1, Edificio Forum, 5º-4ª, 08174 Sant Cugat del Vallès. Barcelona , CIF B66173931, whose purpose is the management, administration and maintenance of the products requested by its customers related to the sale of travel and tourism products in general.

You give your express authorization for your data to be transferred within the sales channel that collaborates with ENJOYTRAVEL CORPORATE, S.L. in the commercialization of its services, as well as to those other persons or entities whose intervention is necessary for the provision of services by ENJOYTRAVEL CORPORATE, S.L. to the client or to respond to requests for products or services made by the client through the Internet services provided by ENJOYTRAVEL CORPORATE, S.L.. This cession can only be used by the assignees for the purpose of information, training and commercialization in relation to the products and services requested by the client.

We also inform you that you can exercise your rights of access, rectification, cancellation and opposition at ENJOYTRAVEL CORPORATE, S.L.'s registered office.

4. Intellectual Property

The intellectual property rights of the Web Site, its source code, design, navigation structure, software, databases and the different elements contained therein are owned by Enjoytravel Corporate, S.L., corresponding to it the exclusive exercise of the rights of exploitation of the same in any form and, in particular, the rights of reproduction, modification, distribution, public communication, transfer, availability and transformation.

All names, designs and/or logos that make up this Website are duly registered trademarks. Any improper use of them by anyone other than their legitimate owner may be prosecuted in accordance with current legislation.

The rights of intellectual property and trademarks of third parties must be respected by anyone who accesses the Web Site, Enjoytravel Corporate, S.L. recognizes in favor of their owners the corresponding rights of industrial and intellectual property, not implying its mere mention or appearance on the Web Site the existence of rights or any responsibility for them, nor endorsement, sponsorship or recommendation.

For the purpose of preserving the possible intellectual property rights, in the event that any user or third party considers that there has been a violation of their legitimate rights by the introduction of certain content on the Web Site, you must notify Enjoytravel Corporate, S.L., indicating:

- Personal data of the interested party.
- Holder of the allegedly infringed rights. In the event that the claim is submitted by a third party other than the interested party, he/she must prove the representation with which he/she is acting.
- Indication of the contents protected by intellectual property rights and their location on the Website.
- Sufficient proof of intellectual property rights.
- Express declaration in which the interested party accepts responsibility for the veracity of the information provided in the notification.

6. Links to other websites

Enjoytravel Corporate, S.L., within the Web Site, may make available to users connections and links to other websites managed and controlled by third parties. Enjoytravel Corporate, S.L. does not sponsor or guarantee any of these third party websites, which have been included for the convenience of users. Therefore, it does not assume any kind of responsibility, not even indirectly or subsidiarily, for damages of any kind that may arise from access, maintenance, use, quality, legality, reliability and usefulness of the contents, information, communications, opinions, statements, products and services existing or offered on websites not managed by Enjoytravel Corporate, S.L. and which are accessible through the Web Site.

Users accept that Enjoytravel Corporate, S.L. reserves the right to withdraw unilaterally and at any time and without prior notice the connections and links that may appear on its Web Site.

7. Content provided by other users on the website

Enjoytravel Corporate, S.L. does not assume responsibility for the content or any type of transmissions that the Users include in its Web Site as well as between Users. The responsibility of the manifestations spread in the Web Site is exclusive of those who make them.

It is forbidden any type of data transmission that the Users make in the Web Site or other accesses controlled by Enjoytravel Corporate, S.L. that infringe practices contrary to good faith, customs, morals or public order; that infringe the property rights of third parties, those of threatening, defamatory, obscene, pornographic, racist, xenophobic, indecent, irreverent, illegal content; that imply an apology of terrorism; that attempt against human rights, or the transmission of any other material that constitutes or incites a conduct that may be considered a criminal offence.

It is forbidden to advertise or offer for sale any kind of goods or services, nor to carry out surveys or contests, nor to send messages requesting their forwarding in chain. Enjoytravel Corporate, S.L., as a general rule, does not review, filter or approve the content of the users. Notwithstanding the foregoing, Enjoytravel Corporate, S.L. reserves the right to remove any content provided by the user that is contrary to the General Conditions, as well as to prevent or prohibit access to the Web Site, all at its sole discretion, without notice and without the user being entitled to any compensation.

If the User believes, at any time, that the contents of another User do not comply with the General Conditions, he/she can notify Enjoytravel Corporate, S.L. by e-mail to the Customer Service Center. Upon receipt of any such notification, Enjoytravel Corporate, S.L. will use its best efforts to remove from its Web Site those contents that may violate the General Conditions.

Enjoytravel Corporate, S.L. will cooperate, if required by court order or by the relevant authorities, in the identification of the persons responsible for those contents that infringe the law.

The user authorizes Enjoytravel Corporate, S.L. to use all or part of the images or contents provided on the website free of charge.

All this with the only exception and limitation of those uses or applications that may violate the right to honor, morality and / or public order, in the terms provided in the legislation in force in each country. Enjoytravel Corporate, S.L. is exempt from liability for any use that a third party may make of such content.

8. Partial nullity

Due to the decentralization of the legislative function and control of the legal framework that affects the activity developed by travel agencies, it is possible that the General Conditions are subject to various jurisdictions or regulations. Therefore, in the event that any condition of the General Conditions is void or voidable, the validity of the same as a whole will not be affected by this circumstance.

The legally ineffective condition shall be replaced by a new condition, or one interpreted in a legally acceptable manner, which is as close as possible in wording to the condition which would have been entered into had the ineffectiveness of the condition in question been known.

9. Enforceability

The fact that Enjoytravel Corporate, S.L. does not demand in one occasion the fulfillment by the User of any condition of the General Conditions, will not affect in any way to its right to demand its fulfillment in a later occasion or to the right of any other party to demand its fulfillment.

Any waiver by Enjoytravel Corporate, S.L. to any of the rights or faculties derived from the General Conditions must be made in writing. The omission by Enjoytravel Corporate, S.L. to require strict compliance with any condition may not be considered in any case as a waiver, nor deprive Enjoytravel Corporate, S.L. the right to subsequently require strict compliance with them.

10. Law and jurisdiction

These General Conditions are governed in each and every one of its aspects by Spanish law and the parties submit to the jurisdiction of the Courts and Tribunals of the city of Madrid, for any actions and claims that may arise from this relationship, as long as a specific jurisdiction is not established by law.

Enjoytravel Corporate, S.L. may offer the opportunity for the User to access its Website in different languages. However, in the event of any conflict or contradictory interpretation between

the General Conditions of the different versions, the Spanish version shall prevail over the rest.
